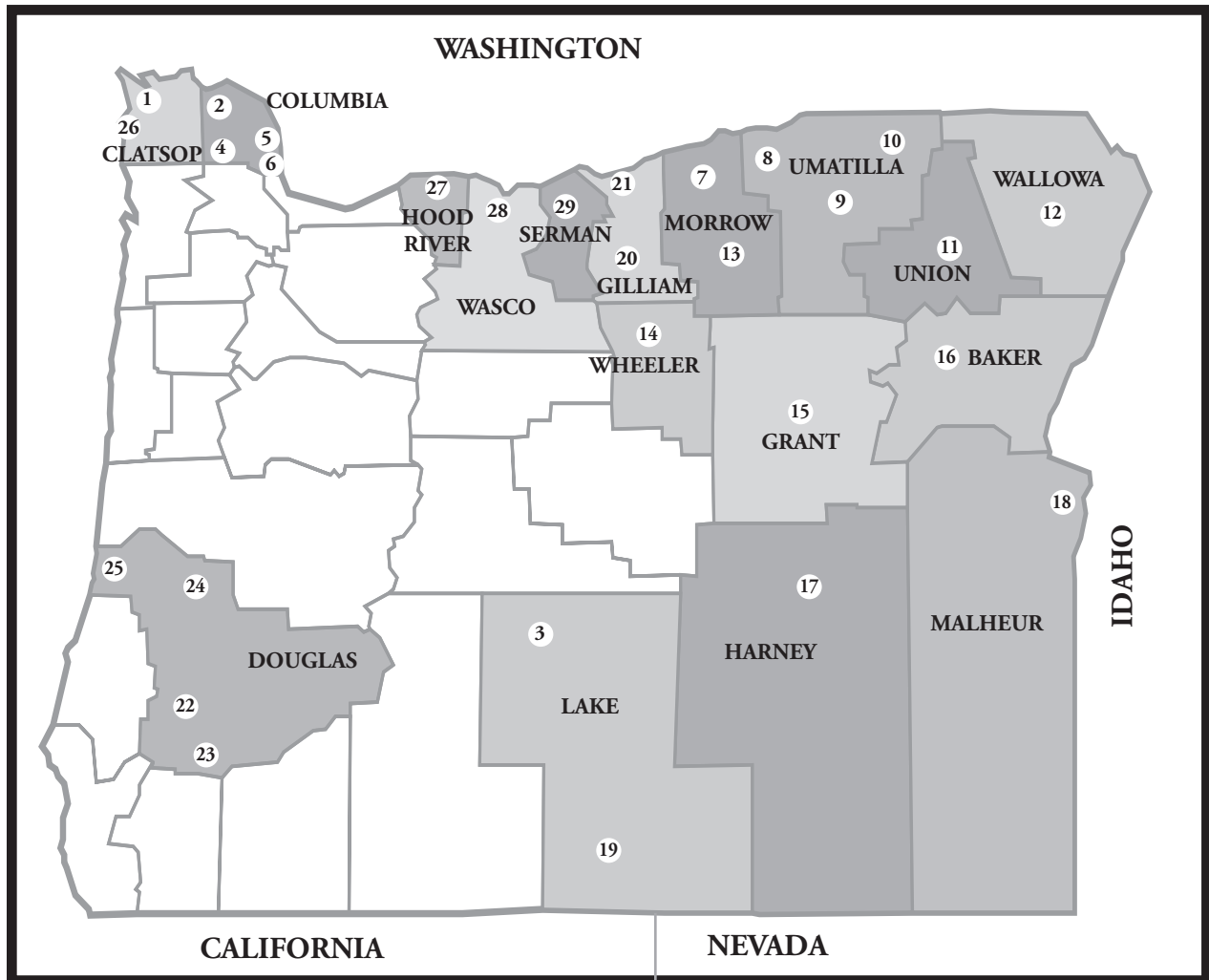


Map of GOBHI Counties
